Important Notes about the CDS for 2003-2004

In previous Common Data Sets, UCD has had a discrepancy in the freshmen cohort for enrollment and graduation/retention rates. Starting with this edition, we have corrected this difference and are complying with IPEDS reporting guidelines. Previously, the grad/retention rates had cohorts that combined both full and part time students because those part-time students took units that did not count towards their degree but were necessary to take degree-counting courses. This change affects sections B1, B4-B11, B22 and C1.
